Adoption of ISO standards on Respiratory Protective Devices postponed by at least six years

Following a long debate and thanks to the joint efforts of SME SAFETY and NORMAPME, CEN TC79 has recently agreed on a roadmap that postpones the vote on the transfer of the ISO 17420 to EN ISO until its first revision. The roadmap leading to the vote will take some six years. If the vote is then positive, another three-year transition period will be given. In total the EN ISO, provided the vote is positive, will come into force in Europe 10 years after publication.

The president of SME Safety, Alberto Spasciani, who takes part in the standardisation process as an Italian representative, welcomed CEN's decision: "SMEs and other stakeholders of RPD products will be able to adopt the ISO approach in a timely and effective manner. On this occasion, CEN has shown that Europe can lead the process of globalisation in order to draw advantage for the competitiveness of European SMEs".

CEN's decision is the result of a wide campaign led by RPD European SME manufacturers in order to inform all stakeholders about the risks of imposing new international standards that are not yet adapted to the needs of European companies. The campaign was orchestrated by NORMAPME – the EU Office of SMEs for standardisation, and has led SMEs to join their forces in a new association called SME Safety that promotes the interests of European SMEs in the European and International standardisation arena.

SME Safety will continue its work in order to improve the ISO standards.
